1. COMMUNITY DEVELOPMENT BLOCK GRANT (CDBG) ALLOCATIONS TO SPECIFIC AGENCIES FOR THE PROVISION OF PUBLIC SERVICE ACTIVITIES, AND
2. HOUSING OPPORTUNITIES FOR PERSONS WITH AIDS (HOPWA) ALLOCATIONS TO SPECIFIC AGENCIES FOR THE PROVISION OF HOUSING AND SUPPORTIVE SERVICES ACTIVITIES.

**Specific CDBG Public Service Activities to Be Added**

<b>ASPIRA of Florida, Inc./City-wide</b>	<b>\$69,962</b>

This agency will provide academic and social enrichment services on behalf of youth and their families.

<b><u>Activity Description/Location</u></b>	<b><u>Estimated Amount</u></b>
<b>Consumer Credit Counseling Service/City-wide</b>	<b>\$38,038</b>

This agency will provide financial and credit counseling services on behalf of households requiring such assistance to primarily include those involved in foreclosure matters.

<b>Fair Housing Center of the Greater Palm Beaches/City-wide</b>	<b>\$25,000</b>

This agency will provide fair housing counseling services.

<b>Urban Youth Impact, Inc.</b>	<b>\$30,000</b>

This agency will provide academic and social enrichment services to youth and their families.

<b>Comprehensive Community Care Network/County-wide</b>	<b>\$2,850,058</b>

This agency will provide short term rent, mortgage and

utility assistance as well as tenant-based rental assistance for persons with HIV/AIDS.

**Activity Description/Location**

**Gratitude House, Inc./County-wide**

This agency serves as a facility-based substance abuse treatment center that will provide housing and supportive services for persons with HIV/AIDS.

**Estimated Amount**

**\$145,000**

**Activity Description/Location**

**The Children's Place at Home Safe, Inc./County-wide**

This agency serves as a facility-based residential shelter that will provide housing and supportive services exclusively for children with HIV/AIDS.

**Estimated Amount**

**\$34,000**

**Activity Description/Location**

**Oakwood Center of the Palm Beaches/County-wide**

This agency will provide facility-based housing and supportive services to persons, who are dually diagnosed with HIV/AIDS, mental and chemical dependency issues.

**Estimated Amount**

**\$525,000**

**Activity Description/Location**

**City of West Palm Beach/County-wide**

The City will use these grant funds to provide for any eligible unforeseen housing and supportive services costs that may arise.

**Estimated Amount**

**\$97,267**
