### **PUBLIC REVIEW A DRAFT COPY OF THE CITY OF WEST PALM BEACH'S 2010-2015 CONSOLIDATED PLAN/2010 ACTION PLAN**

The City of West Palm Beach, FL will solicit comments on its DRAFT FY2010- 2015 Consolidated Plan and 2010 Action Plan for the time period of October 1, 2010 to September 30, 2015 at a Public Hearing to be held on **Thursday, July, 22, 2010** at 7:00 p.m. at the Coleman Park Community Center located at 1116 21<sup>st</sup> Street, West Palm Beach, Florida 33401.

The City of West Palm Beach is an entitlement community eligible to receive assistance under the U. S. Department of Housing and Urban Development [HUD] Community Development Block Grant [CDBG] Program, HOME Investment Partnerships [HOME] Program and Housing Opportunities for Persons With AIDS [HOPWA] Program. As mandated by Federal Regulation, 24 CFR Part 91, the City of West Palm Beach is required to document its plan to pursue these goals for all the community planning and development programs, as well as for housing programs in its Strategic Consolidated Plan [ConPlan].

The ConPlan is a three-to five-year, long-range strategic plan submitted to the U.S. Department of Housing and Urban Development [HUD] to identify, prioritize and address the City of West Palm Beach's housing and community development needs and to develop a map of the planned use of available housing and community development funds from all sources. The Consolidated Plan also serves as the planning document for the City of West Palm Beach and as an application for funding under the referenced programs which is prepared in accordance with the requirements of 24 CFR Part 91.

This report provides a preview of activities to be carried out under the Community Development Block Grant [CDBG], the Home Investment Partnerships [HOME] and the Housing Opportunities for Persons With AIDS [HOPWA] formula grant programs to address the needs of the low and moderate income citizens, the homeless, the elderly, and the mentally and/or physically disabled persons in the community, to include persons living with HIV/AIDS.

Copies of the 2010-2015 Consolidated Plan/ 2010 Action Plan will be available for examination and comment by the public beginning **Friday, July 9, 2010** , at the City of West Palm Beach Housing and Community Development Office, located at 401 Clematis Street, WPB, FL 33401, [Telephone: 561-822-1250]. Office hours are Monday through Friday from 8:00 A.M. to 5:00 P.M. The required public review period begins **Friday, July 9, 2010** and ends **Monday, August 9, 2010**. The City of West Palm Beach will receive written comments until 5:00 P.M. on **Monday, August 9, 2010**.
